### Schedule of Conditions of Entry

<b>What is the name of the competition?</b>	<i>NAB Mini Legends Draft 2017</i>
<b>Who is entitled to enter the competition (the “Entry Requirements”)?</b>	<ul style="list-style-type: none"><li>• <i>Entrants (nominees) must be aged between 5 – 12 years old.</i></li><li>• <i>Must be an Australian citizen, located in Australia.</i></li><li>• <i>Must have parental/guardian consent.</i></li></ul>
<b>Who is not allowed to enter the competition (the “Ineligible Entrants”)?</b>	<ul style="list-style-type: none"><li>• <i>Any NAB employees, agents, or contractors (and immediate family members) who are directly involved in the judging of the winners.</i></li></ul>
<b>What is the applicable State or Territory (the “Applicable State/s”)?</b>	<i>Australia Wide</i>
<b>How does someone enter the competition (the “Entry Method”)?</b>	<p><i>To nominate a child, the parent/guardian must visit the NAB website at <a href="http://nab.com.au/afl">nab.com.au/afl</a> complete the on-line form, and submit a one minute video of the Entrant (Nominee).</i></p> <p><i>By entering a child in this competition, the parent/guardian warrants that he or she has agreed to the Conditions of Entry and gives consent for their child to take part in this competition, including participating in any promotional activities (such as publicity and photography) and the use of their child's name and image in any promotional material.</i></p>
<b>When will the competition run (the “Competition Period”)?</b>	<p><i>The competition opens on Tuesday, 27<sup>th</sup> June 2017 at 12pm (midday) - Melbourne time.</i></p> <p><i>Entries close on Tuesday, 11<sup>th</sup> July 2017 at 12pm (midday) - Melbourne time.</i></p>
<b>What is the maximum number of entries per Entrant (the “Maximum Number of Entries”)?</b>	<p><i>Only one video may be submitted per Entrant (nominee) during the competition period.</i></p>
<b>How will the winners and runners up be chosen (the “Entry Criteria”)?</b>	<p>Entrants (nominees) will be judged on the following criteria:</p> <ul style="list-style-type: none"><li>• <i>Children that best have a likeness to, and act (play) like, the AFL or AFLW player they are trying to emulate.</i></li><li>• <i>Entrants (nominees) must be aged between 5-12 years old.</i></li><li>• <i>Video submissions must NOT have a music track playing in the background otherwise the entrant (nominee) will be disqualified.</i></li><li>• <i>Video submissions must be no longer than one minute in length.</i></li><li>• <i>Video submissions must be culturally sensitive.</i></li><li>• <i>Submissions for player likeness which appeared in last year's Mini legends campaign will not be accepted..</i></li></ul>

<p><b>Do any special conditions need to be met for the winner to accept the prize?</b></p>	<p><i>The Prize is not transferable or exchangeable and cannot be redeemed for cash. <p><b>What are the details and value of each prize (the “Prize”)?</b></p>	<p><i>The prize is the opportunity for two winners to star in the 2017 NAB AFL Campaign Commercial (and associated collateral e.g. AFL Record). This will include the following for each of the two winners, who will receive:</i></p> <ul style="list-style-type: none"> <li>• <i>Casting fees to appear in the TV ad and other promotional material \$2,500.</i></li> </ul> <p><i>If the winner is not from Melbourne, the following will also apply:</i></p> <ul style="list-style-type: none"> <li>• <i>Flights for winner and one parent/guardian to and from preproduction and production locations, if interstate – varies depending on location. Maximum value approx. \$2,000.</i></li> <li>• <i>Twin share accommodation will be provided for the period of stay to attend pre-production and production. Maximum 6 nights’ accommodation. Maximum value approx. \$2,000 per winner</i></li> <li>• <i>Transfers from airport and from hotel (if applicable)</i></li> </ul>

<b>How are prizes to be claimed?</b>	<p><i>The prize will be organized and paid for via Clemenger BBDO.</i></p> <p>The flights, accommodation and transfers will be booked via email and phone.</p> <p>The casting fees will be transferred to the winner's nominated bank account via electronic funds transfer.</p>
<b>What is the total value of all prizes (the "Total Prize Pool")?</b>	<p><i>The total prize pool (per winner) is up to \$6,750 (incl. GST), depending on the location of the winners and length of stay required to attend both shoot dates.</i></p> <p><i>The total prize pool for the competition is up to \$13,500.</i></p>

<b>When must the winner(s) claim their prize(s) (the "Prize Claim Date and Time")</b>	<i>The winners must respond by 5pm Melbourne time Thursday, 20<sup>th</sup> July 2017. Otherwise the winner will forfeit their prize.</i>

## ***Conditions of Entry***

1. These Conditions of Entry must be read together with the Schedule. By entering, entrants accept these conditions.
2. Entry is open to residents of the Applicable State/s who comply with the Entry Requirements (if any). Entries submitted by Ineligible Entrants are not accepted. If entry is permitted to persons under 18, those entrants must first obtain consent of their parent or guardian.
3. The competition will be run during the Competition Period.
4. The Prize is not transferable or exchangeable and cannot be redeemed for cash. If a winner does not take a part of the Prize at the time set by NAB, the winner will forfeit that part. NAB accepts no responsibility for changes in Prize value. If a Prize is unavailable, NAB will substitute it for one of equal or greater value.
5. To enter, entrants must follow the Entry Method, noting any Entry Details, and submit their entries during the Competition Period.
6. Entrants may only submit up to the Maximum Number of Entries.
7. All valid entries will be entered into the competition. Entries must be received during the Competition Period. NAB has no control over telecommunications networks and accepts no responsibility for problems associated with them. Entries are deemed received at the time of receipt into NAB's database, not at the time of transmission. Entries submitted using any form of automated entry device or software are ineligible. Entries not fully complying with these Conditions of Entry will be deemed invalid. NAB accepts no responsibility for late, lost, incomplete, delayed, corrupted, illegible or misdirected entries whether due to error, omission, alteration, deletion, destruction, transmission interruption, tampering, theft, destruction failure or otherwise.
8. The best valid entry as determined by the judges according to the Entry Criteria will win the Prize described in the Schedule. The Total Prize Pool is set out in the Schedule.
9. This is a Game of Skill and chance plays no part in determining winners. Each valid entry will be individually judged on the basis of the Entry Criteria. The judges' decision will be final and no correspondence will be entered into.
10. All entries will become NAB's property. Each entry must be the entrant's original work and entrants agree that NAB may make copies of or publish their entry in any form or media. Entrants warrant that their entry is not, and its use by NAB will not be, in breach of any person's intellectual property rights or any other rights.
11. In consideration for awarding a Prize to a winner, following the consent of their parent(s) or legal guardian(s), winners agree to participate in any promotional activity regarding winning the Prize and consent to their name and image being used in promotional material.
12. Where a Prize consists of travel, travel may be restricted to periods other than peak periods and must be booked and completed in accordance with any terms prescribed by NAB and/or the travel arranger. If the Prize is event based, travel must coincide with the event dates. Flights and accommodation are subject to availability.
